MW & Security CSP Voucher (Cloud Solution Provider) | Pilot Overview



Leverage this program to accelerate your eligible opportunities by positioning a limited time offer for deployment funds through eligible partners. Effective Period: April 7, 2025 to June 30, 2025 (or earlier, if all vouchers have been claimed)

- CSP in New Commerce Only
- Corporate Commercial accounts WW (excludes Public Sector & SMB)
- Account must have an MSX opportunity with a closing date in FY25 and Co-sell Partner attached to opportunity
- Active, open new opportunity for ME3 and/or ME5
- Minimum opportunity 500 seats
- Purchasing Pricing Type=New. Excludes renewals.
- CSP Customers with annual commit and annual payment

This offer is to be used as a deal accelerant during pre-sales, the opportunity must be nominated and conditionally approved before the deal closes.

Voucher Criteria

Eligibility

- 1. CSP in New Commerce Only
- Only one CSP Voucher for Microsoft 365 claim allowed per TPID.
- 3. Only the transacting CSP partner can claim the Voucher. (but will honor customer choice)
- 4. Payment is subject to SOW and POE submission approval.
- 5. Nomination submitted and approved prior to deal close
- 6. Excludes public sector customers

Voucher Value

- Voucher value: 8% of Year 1 CSP Estimated Retail Price (ERP) of ME3/ME5 on the opportunity once closed as won. Up to \$50k/voucher.
- Minimum deal size for M365 E3/E5 is 500 seats for Corporate Commercial accounts (SME&C Corporate) (excludes Public Sector & SMB)
- Example Payout: 500 ME3 (No Teams) Seats*
 <u>ERP=\$33.75</u>*12months*8%=
 \$16,200 voucher

Award

- The voucher MUST be communicated to the customer during pre-sales once the voucher slot is confirmed
- Final approval occurs after revenue is booked and the deal has closed in MSSales
- Once awarded, the voucher must be claimed within six months
- 30% of the voucher value is paid to the partner once the Statement of Work (SOW) is accepted. 70% is paid based on Proof of Execution (POE) for finalized work signed off by the customer.
- No exceptions nor extensions
 available

Customer Nomination & Approval Process



Nomination

- 1. Sellers review list of eligible opportunities within MSX.
- 2. Seller Role includes, Specialist, Technical Specialist, AE, SSM, TSM
- 3. Sellers must ensure Co-sell Partner is attached to the opportunity
- 4. Partners not listed please see onboarding process
- 5. Eligible customers are nominated using the <u>Customer Nomination</u> <u>Form</u>
- 6. Nominations reviewed to check against eligibility criteria* by the program team



- Approval or rejections are communicated within 1-2 business days
- 2. Example Payout: 500 ME3 (No Teams) Seats** ERP=\$33.75*12months*8% = \$16,200 voucher
- Within 14 business days after deal closure of a conditionally approved nomination and MSX status updated as Won, account team representative must notify <u>mwdepoffersupport@mi</u> <u>crosoft.com</u> to confirm win details and authorize release of youcher to the customer



Customer Notification

- Once the seller receives the Nomination Approval, can use the Deployment Offer Customer Letter to communicate offer.
- 2. Once landed revenue has been confirmed, voucher will be issued directly to the customer with Opportunity Owner cc'd



Redemption

- 1. The partner is copied on voucher issuance to the customer
- 2. The partner starts the redemption process by submitting applicable documents
- 3. Vouchers must be redeemed by Partners no later than 6 months after the voucher has been issued

*Includes compliance check for "Double Dipping" **Program offer rules are subject to change throughout the fiscal year

	Nomination	 If Partner is eligible but not yet onboarding or approved, Onboarding Team will send an email to have partner self-nominate for program
	Onboarding	 Partner must review and sign Terms & Conditions to be approved into program Partner contact (as per nomination form) will receive an onboarding package Partner must then complete Payment Central details to receive funds


